**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), dated as of December 31, 2018, is made by BANK OF AMERICA, N.A., with offices located at One Bryant Park, New York, New York 10036, in its capacity as Collateral Agent (the “**Assignor**”), in favor of ARMSTRONG FLOORING, INC., a Delaware corporation with offices located at 2500 Columbia Avenue, Lancaster, Pennsylvania 17604-3001, ARMSTRONG HARDWOOD FLOORING COMPANY, a Tennessee corporation with offices located at 2500 Columbia Avenue, Lancaster, Pennsylvania 17604-3001, ARMSTRONG WOOD PRODUCTS, INC., a Delaware corporation with offices located at 2500 Columbia Avenue, Lancaster, Pennsylvania 17604-3001 and AFI LICENSING LLC, a Delaware limited liability company with offices located at 2500 Columbia Avenue, Lancaster, Pennsylvania 17604-3001 (together, the “**Assignees**”).

W I T N E S S E T H:

**WHEREAS**, the Assignees and the Assignor are parties to that certain Security Agreement, dated as of April 1, 2016 (the “**Security Agreement**”);

**WHEREAS**, pursuant to the Security Agreement, the Assignees granted a continuing security interest in and continuing lien upon, the trademarks and trademark applications set forth on Schedule I (collectively, the “**Trademark Collateral**”) to the Collateral Agent for the ratable benefit of the holders of the Secured Obligations.

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office on October 17, 2016 at Reel/Frame No. 5900/0736; and

**WHEREAS**, the Assignees desire that the Assignor terminate and release its lien on and security interest in and to all right, title and interest in, to and under all of the Trademark Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Security Agreement.

**SECTION 2. Termination and Release.** The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its lien on and security interest in and to all right, title and interest in, to and under the Trademark Collateral, including the trademarks listed on Schedule I attached hereto, and reassigns and transfers to the Assignees all right, title and interest that the Assignor may have in the Trademark Collateral.

**SECTION 3. Recordation.** The Assignor hereby authorizes the Assignees, or the Assignees' authorized representative, to record this Release with the United States Patent and Trademark Office.


