**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 31, 2018 (the “Effective Date”), is made by UBS AG, STAMFORD BRANCH, in its capacity as Collateral Agent (the “Agent”), in favor of VERICLAIM, INC. (“Vericclaim” or “Grantor”).

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of February 28, 2014, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Collateral Agent for the benefit of the secured parties, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, Vericclaim executed and delivered a Grant of Security Interest in Trademark Rights, dated as of September 30, 2014 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on October 2, 2014 at Reel/Frame 5373/0036.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Collateral (as defined in the Trademark Security Agreement), including the trademark registrations and applications set forth Exhibit A attached hereto (collectively, the “Trademark Collateral”), arising under the Security Agreement and the Trademark Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to Trademark Collateral under the Trademark Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.


3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of state of New York, without regard to conflicts of law or choice of law principles.
