RELEASE FROM NEGOTIABLE SECURITY PROMISSORY NOTE

This Release, dated November 21, 2017 is given BY the Releasor, Pasaporte Latino Inc. a New York Corporation with principal office at 415 East 37<sup>th</sup> Street, Apt 9F, New York, New York 10016 herein referred to as "Lender." TO Apoc Restaurant, Inc., a New York corporation with principal office address 760-768 8<sup>th</sup> Avenue, New York, New York 10036 herein referred to as "Borrower."

1. Release. Lender releases and gives up any and all claims and rights which Lender may have against Borrower whether known or unknown. This includes, but is not limited to, all claims that could have been presented against Lender in connection with a COLLATERAL SECURITY AGREEMENT from Borrower to Lender dated May 11, 2011. This NEGOTIABLE SECURITY PROMISSORY NOTE was executed along with the COLLATERAL SECURITY AGREEMENT from Borrower to Christian Naselli dated May 11, 2011.
2. Consideration. Lender has been paid in full (\$225,000.00) plus interest (\$21,000.00) on the NEGOTIABLE SECURITY PROMISSORY NOTE for making this Release. The interest check is being paid directly to Christian Naselli at Lender's request. Lender agrees that Lender shall not seek any further payment from Borrower and releases any claims to the Borrower and to the business DBA Copacabana. Lender had the option of choosing a 5% ownership in the Copacabana business or receive interest on this Note. Lender has chosen to receive the interest payment. Accordingly, the Lender agrees that the Lender has been completely paid in full all of the Obligations and that this NEGOTIABLE SECURITY PROMISSORY NOTE is terminated.
3. Who is Bound. The Lender is bound by this Release. Anyone who succeeds to Lender's rights and responsibilities, such as Lender's successors or assigns, is also bound. This Release is made for the Borrower's benefit and all who succeed to Borrower's rights and responsibilities, such as Borrower's heirs or the executor of Borrower's estate or Borrower's successors or assigns.
