This **RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is executed as of December 21, 2018, 2018, by **CITIZENS BANK, N.A. WHEREAS, Administrative Agent wishes to release the security interest in and lien on the Trademark Collateral, including, without limitation, the Trademark Collateral identified on Schedule A attached hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent states as follows:

Administrative Agent hereby terminates and releases its security interest in and lien on the Trademark Collateral, and Administrative Agent hereby assigns and transfers to the Released Party, without recourse or representation or warranty, express or implied, of any kind, all of its right, title, and interest in and to the Trademark Collateral, including, without limitation, each of the trademarks applications or registrations identified on Schedule A attached hereto, effective as of the date set forth above.


This Release shall be governed by the laws of the State of Delaware and shall relate solely to the Security Agreement.
