**ASSIGNMENT OF INTANGIBLE PROPERTY**

This Assignment of Intangible Property (this "*Assignment*") is made as of September 21, 2018 by (a) Entercom California, LLC, CBS Radio Stations Inc., CBS Radio of Northern California, LLC (as successor by merger to CBS Radio KMVQ Inc.), CBS Radio Media Corporation (collectively, "*Entercom*") and (b) TDC Communications, LLC as trustee of The Entercom Divestiture Trust (the "*Trust*," and together with Entercom, the "*Entercom Parties*"), and (c) Bonneville International Corporation ("*Buyer*").

WHEREAS, Entercom, with a place of business at 401 E. City Avenue, Suite 809, Bala Cynwyd, Pennsylvania 19004, and the Trust, with a place of business at c/o MVP Capital, LLC, 255 California Street, Suite 850, San Francisco, CA 94111, are the owners of the Intangible Property, including those items that are identified in Schedule 1.1(d) of the Asset Purchase Agreement and attached as Exhibit A hereto (the "*Intangible Property*") and desire to assign all of their right, title and interest in, to and under the Intangible Property, to Buyer;

WHEREAS, Buyer, with a place of business at 55 North 300 West, 2nd Floor, Salt Lake City, Utah 84101, desires to obtain all of the Entercom Parties' rights in, to and under the Intangible Property; and

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "*Asset Purchase Agreement*"), dated as of August 2, 2018, by and among the Entercom Parties, Buyer and Bonneville Media of San Francisco, LLC, Entercom Parties have agreed to assign all of their right, title and interest in, to and under the Intangible Property to Buyer.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Asset Purchase Agreement, the Entercom Parties hereby unconditionally and irrevocably grant, bargain, sell, assign, transfer, convey, and deliver to Buyer all of the Entercom Parties' right, title and interest in, to and under the Intangible Property, whether statutory or at common law, free and clear of all Liens (other than Permitted Liens), including all registrations and applications therefor, the right to recover for past infringement, and the goodwill associated with such Intangible Property in the operation of the business of radio broadcast stations.



This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without regard to principles of conflict of laws and Federal law, as applicable.




