TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made this 21st day of December, 2018 (the "Release Date") by Wilmington Trust, National Association (as successor-in-interest to Société Générale), as Administrative Agent and as Collateral Agent (the "Agent"), for the benefit of the Grantors under the Security Agreement (as defined below) (collectively, the "Debtors"), as applicable.

WHEREAS, the Debtors, as Grantors thereunder, have entered into that certain Second Lien Guaranty Security Agreement, dated as of December 13, 2013 and the Second Lien Trademark Security Agreement, dated as of December 13, 2013 (the "Trademark Security Agreement" and together with the Second Lien Guaranty Security Agreement, in each case, as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Security Agreement"), with Agent, in its capacity as collateral agent for the Lenders (in such capacity, the "Collateral Agent"), pursuant to which the Debtors granted to the Collateral Agent and each other Secured Party a continuing security interest and lien in and to the Trademark Collateral (as such term is defined in that certain Second Lien Trademark Security Agreement dated as of December 13, 2013 by and among the entities signatory thereto as Grantors in favor of the Agent as Collateral Agent thereto for the Lenders and the L/C Issuers), including, without limitation, all trademarks, service marks, trade names, trade dress, Internet domain names or other indicia of trade origin, whether registered or unregistered, trademark and service mark registrations, and applications for trademark or service mark registrations and any renewals thereof, including, without limitation, each registration and application identified in Exhibit A attached hereto and made a part hereof, and including, without limitation, (i) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iii) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Debtors accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress, Internet domain name or other indicia of trade origin (collectively, the "Marks", and each, a "Mark");

WHEREAS, Agent has recorded with the United States Patent and Trademark Office (the "<u>USPTO</u>") on December 13, 2013 at Reel 5173, Frame 0616, notices of security interests in the Marks; and

WHEREAS, all outstanding amounts owed under any financing documents executed in connection with the Security Agreement have been satisfied and the Debtors have requested that Agent release its security interest in the Marks.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent agrees as follows:

- 1. <u>Release of Security Interest</u>. Effective as of the Release Date, Agent hereby irrevocably and forever terminates, releases and discharges any and all security interests in the Marks granted by the Debtors under the Security Agreement.
- 2. <u>Recordation of Release</u>. Agent understands and agrees that this Release may be recorded by or for the Debtors with the USPTO.
- 3. <u>Further Actions</u>. Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtors may reasonably request to effect the intent and purpose of this Release, <u>provided that</u> all such documents are to be prepared by counsel to the Debtors and the cost and expense of such documents and actions shall be borne solely by the Debtors.
- 4. <u>Capitalized Terms</u>. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement, as applicable.
