**ARTICLES OF CONVERSION OF
INTUITIVE TECHNOLOGY GROUP, LLC
INTO
INTUITIVE TECHNOLOGY GROUP, INC.**

These Articles of Conversion are being submitted for filing with the Minnesota Secretary of State for the purpose of converting Intuitive Technology Group, LLC, a Minnesota limited liability company, into a Minnesota corporation under the name “Intuitive Technology Group, Inc.” pursuant to the Minnesota Limited Liability Company Act (the “Act”) and the Minnesota Business Corporation Act. The undersigned, being duly authorized to execute and file these Articles of Conversion, does hereby certify as follows:

The Plan of Conversion, in a form required by Section 322B.781 of the Act, is attached to these Articles of Conversion as Exhibit A (the “Plan of Conversion”) and is hereby made a part of these Articles of Conversion.

1. The name of the converting organization immediately before the filing of these Articles of Conversion is Intuitive Technology Group, LLC (the “Converting Organization”).
2. The Converting Organization is a Minnesota limited liability company governed by Chapter 322B of the Minnesota Statutes.
3. Upon the effectiveness of these Articles of Conversion, the name of the Converting Organization will be changed to Intuitive Technology Group, Inc. (the “Converted Organization”).
4. The Converted Organization will be a Minnesota corporation governed by Chapter 302A of the Minnesota Statutes.
5. Under the governing statute of the Converted Organization, these Articles of Conversion shall be effective upon filing with the Minnesota Secretary of State.
6. The conversion of the Converting Organization has been approved by the members of the Converting Organization in the manner required under Chapter 322B of the Minnesota Statutes.
7. The Articles of Incorporation of the Converted Organization shall be those attached as Schedule I to the Plan of Conversion.



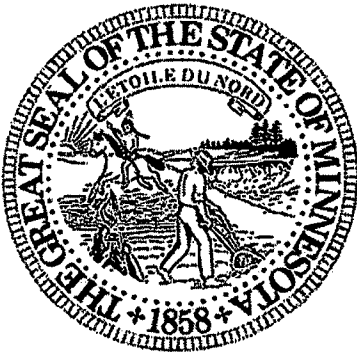
