RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made as of January 3, 2018, by COMERICA BANK, a Texas banking association ("Lender") in favor of SIRIUSDECISIONS, INC., a Delaware corporation ("Company") with its principal place of business located at 187 Danbury Rd., Wilton, CT 06897. Terms used but not defined herein shall have the meanings given to them in the Security Agreement (as defined below) or the Loan Agreement (as defined therein), as applicable.

RECITALS

WHEREAS, pursuant to an Intellectual Property Security Agreement, dated as of March 31, 2016 (the "Security Agreement"), and recorded with the US Patent and Trademark Office as set forth on Exhibit A, Company granted and pledged to Lender a security interest in all of Company's right, title and interest in, to and under its Intellectual Property Collateral (including, without limitation those Trademarks described on Exhibit A), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

WHEREAS Company has no outstanding obligations to Lender under the terms of the Security Agreement, and Lender agrees to release its security interest in the Intellectual Property Collateral.


AGREEMENT

Now therefore, Lender hereby terminates and releases its security interest in all of Company's right, title and interest in, to and under the Intellectual Property Collateral and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property Collateral. Lender hereby authorizes Company, or Company's authorized representative, to record this Release with the US Patent and Trademark Office.
