## RELEASE OF SECURITY INTEREST IN TRADEMARK

This Release of Security Interest in Trademark (this "Release") is made as January 2, 2019 and granted by BANK OF AMERICA, N.A. (the "Collateral Agent"), in its capacity as collateral agent pursuant to that certain Amended and Restated Pledge and Security Agreement dated as of May 29, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement") by and among HOLOGIC, INC., a Delaware corporation (the "Borrower"), certain subsidiaries of the Borrower from time to time party thereto, and the Collateral Agent. Capitalized terms used herein have the meanings attributed thereto in the Pledge and Security Agreement unless otherwise defined herein.

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of September 12, 2018 (the "Trademark Security Agreement"), between FAXITRON BIOPTICS, LLC, as grantor (the "Grantor") and the Collateral Agent, which was recorded with the United States Patent and Trademark Office on September 20, 2018 on Reel 006441 Frame 0803, the Grantor pledged to the Collateral Agent, for the benefit of the Secured Parties, a Security Interest in and continuing lien on the Trademark listed on Schedule I hereto in error; and

**WHEREAS**, the Grantor has requested that the Collateral Agent release the entirety of its Security Interest in and lien on the Trademark listed on Schedule I and the Collateral Agent has agreed to do so.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby states as follows:

1. Release of Security Interest. The Collateral Agent hereby terminates, cancels, discharges and releases its Security Interest in and any lien on the Trademark listed on Schedule I, without warranty or recourse.
2. Further Assurances. The Collateral Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, in each case at the Grantor's sole expense.
3. Governing Law. This Release shall be construed in accordance with and governed by the law of the State of New York.
