

Pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), Accor Business and Leisure North America, LLC, a Florida limited liability company (the "LLC"), hereby certifies as follows:

FIRST: The name and state of organization of each of the constituent entities to the merger (the "Merger") are as follows:
