NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Trademark Release"), effective as of December 19, 2018, is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION** (as successor-in-interest to First Union National Bank) (the "Lender") in favor of **BDP INTERNATIONAL, INC.**, a Pennsylvania corporation (the "Grantor").

WITNESSETH:

WHEREAS, reference is made to the Loan and Security Agreement, dated as of September 20, 1999 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and between the Lender and the Grantor;

WHEREAS, pursuant to the Loan Agreement, the Grantor executed and delivered the Trademark Security Agreement, dated as of September 20, 1999 (the "Trademark Security Agreement") with Lender, which was recorded with the United States Patent and Trademark Office on October 1, 1999 at Reel/Frame No. 1973/0325;

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted and pledged to the Lender a lien on and security interest in all of its present and future right, title and interest in and to the Trademarks (including without limitation those Trademarks listed on Schedule A hereto (the "Trademark Collateral"));

WHEREAS, the Lender desires to terminate and release its lien on and security interest in all such Trademark Collateral and has duly authorized the execution, delivery and performance of this Trademark Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender agrees, for the benefit of the Grantor, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Trademark Release, including its preamble and recitals, have the meanings provided or provided by reference in the Loan Agreement or the Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Lender does hereby release, relinquish, terminate and discharge its lien on and security interest in the Trademark Collateral, and hereby assigns, transfers and conveys to the Grantor, any right, title, or interest it may have in the Trademark Collateral.

SECTION 3. Termination. The Lender, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Further Assurances. The Lender hereby authorizes the Grantor or the Grantor's authorized representative to (i) record this Trademark Release with the United

States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Lender in the Trademark Collateral and/or (iii) otherwise record or file this Trademark Release in the applicable governmental office or agency. The Lender further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or its agents or designees) reasonably request (at the Grantor's sole cost and expense) in order to confirm this Trademark Release and the Grantor's right, title and interest in, to and under the Trademark Collateral.

SECTION 5. Choice of Law. This Trademark Release and the rights and obligations of the parties under this Trademark Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to any principle of conflicts of law that could require the application of any other law.

SECTION 6. Counterparts. This Trademark Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Delivery of an executed counterpart to this Trademark Release by facsimile or other electronic transmission shall be as effective as delivery of a manually signed original.
