**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of January 4, 2019 (the "Effective Date"), is made by **BANK OF AMERICA, N.A.**, a United States association with an address at 901 Main Street, Code TX1-492-14-06, Dallas, Texas 75202, in its capacity as collateral agent (the "Collateral Agent"), in favor of **HARD ROCK CAFE INTERNATIONAL (USA), INC.**, a Florida corporation with an address at 6100 Old Park Lane, Orlando, Florida 32835, **SEMINOLE HARD ROCK ENTERTAINMENT, INC.**, a Florida corporation with an address at 5701 Stirling Road, Davie, FL 33314, and **SEMINOLE HARD ROCK INTERNATIONAL, LLC**, a Florida limited liability company with an address at 5701 Stirling Road, Davie, FL 33314 (collectively, the "Pledgors").

WHEREAS, Pledgors entered into a certain trademark security agreement dated March 9, 2018 (the "Trademark Security Agreement") with Collateral Agent, notice of which was recorded on March 12, 2018 at the United States Patent and Trademark Office at Reel 6289, Frame 0728.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Pledgors granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to their Trademarks, all Goodwill associated with such Trademarks, and all Proceeds of such Trademarks (collectively, the "Trademark Collateral"), including the Trademarks listed in Schedule 1.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgors, and assigns, transfers and conveys to Pledgors any interest in such intellectual property, including the Security Interest.
