RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this “Release”) is made as of December 18, 2018 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the “Administrative Agent”) for the Secured Parties (as defined in the Credit Agreement referred to in the Security Agreement (as defined below)).

WITNESSETH:

WHEREAS, RALEY’S, a California corporation (“Raley’s”), RALEY’S TM INC., a California corporation (“TM”) and WAREHOUSE CONCEPTS, a California corporation (“Warehouse” and together with Raley’s and TM, each a “Grantor” and collectively, the “Grantors”) executed that certain Trademark Security Agreement, dated as of May 18, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of the Administrative Agent, pursuant to which the Grantors granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of Grantors; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 5521, Frame 0681 on May 21, 2015; Reel 5521, Frame 0722 on May 21, 2015; and Reel 5521, Frame 0761 on May 21, 2015; and

WHEREAS, the Administrative Agent has agreed to release all its liens on the trademarks and trademark applications of the Grantors identified on Exhibit A attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.


NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Administrative Agent’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.

For the avoidance of doubt, this Release does not affect and does not relate to (i) that certain Amended and Restated Credit Agreement, dated on or about May 18, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Revolver Credit Agreement”), among Raley’s, as the Lead Borrower (as defined in the Revolver Credit Agreement), Wells Fargo Bank, National Association, as the Administrative Agent, Collateral Agent, and Swing Line Lender (each as defined in the Revolver Credit Agreement) and the lenders from time to time party thereto, (ii) any other Loan Documents (as defined in the Revolver Credit Agreement) or (iii) any grants of security interest in connection therewith.
