**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release (this "*Release*") is made with regard to that certain Trademark Security Agreement entered into as of June 29, 2018 (the "*Agreement*") by and between SILICON VALLEY BANK (the "*Lender*") and OH MY GREEN, INC. (the "*Company*").

WHEREAS, Lender agreed to make certain advances of money and to extend certain financial accommodations to the Company in the amounts and manner set forth in that certain Loan and Security Agreement by and between Lender and the Company dated February 16, 2017 (as amended to date, the "*Loan Agreement*").

WHEREAS, pursuant the Loan Agreement, the parties entered into the Agreement, which was recorded on July 5, 2018 at Reel 006573 Frame 0077 in the U.S. Patent and Trademark Office, the Company granted the Lender a security interest (the "*Security Interest*") in certain Intellectual Property Collateral, as defined in the Agreement, including the trademark listed in Trademark Schedule A hereto (the "*Trademark*").

WHEREAS, the Company has paid and satisfied in full its obligations under the Loan Agreement, and the parties desire to enter into this Release to confirm that the Lender has released its security interests in and to the Intellectual Property Collateral and to expunge any recordation of the Security Interest insofar as it pertains to the Intellectual Property Collateral.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender forever releases and discharges the entire Security Interest in and to all of the Intellectual Property Collateral, including the Trademark, granted to the Lender by the Agreement.

The Lender hereby agrees to execute such instruments, to take such other actions, and to give such further assurances as the Company reasonably shall request to terminate any security interest in the Intellectual Property Collateral pursuant to the Agreement and otherwise to effectuate the release of all recordations of such Security Interest.

The Lender acknowledges and agrees that the Company and its successors and assigns may rely upon this Release. The Lender represents and warrants that it has not transferred or assigned all or any part of the Security Interest in the Intellectual Property Collateral to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.
