**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 4, 2019 ("Release"), is made by Village Bank & Trust (including all secured parties, collectively, the "Bank") in favor of The Vertex Companies, Inc., a Delaware corporation ("Pledgor").

WHEREAS, pursuant to that certain Security Agreement dated as of December 16, 2016 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Pledgor, Bank, and others party thereto, Pledgor granted to the Bank a security interest in all trademarks, service marks, and trade names and all goodwill connected with or symbolized with the foregoing (collectively, "Trademark Collateral"); and

WHEREAS, pursuant to the Security Agreement, Pledgor executed and delivered to Bank the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on December 19, 2016 at Reel 5940 Frame 0021 ("Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in the Trademark Collateral listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.

SECTION 4. Acknowledgement. The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Security and Pledge Agreement dated as of January 4, 2019 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time) by and among the Pledgor, Village Bank & Trust., in its capacity as administrative agent thereto, and others party thereto.
