RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 23rd day of August, 2018, by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as agent ("Agent"), in favor of MERCURYGATE INTERNATIONAL, INC., a Florida corporation ("Company").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Agent hereby absolutely, unconditionally and irrevocably releases, discharges, terminates and cancels all of its liens and security interests granted by Company in favor of Agent in the Trademark Collateral (as defined in the Trademark Agreement) pursuant to the Trademark Agreement including the trademark registrations and applications set forth on Schedule A attached hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark and all products and proceeds of the forgoing, including without limitation, any claim by Company against third parties for past, present or future (a) infringement or dilution of any Trademark included in the Trademark Collateral, or (b) injury to the goodwill associated with any such Trademark.


If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral, together with the goodwill of the business connected with the use thereof

and symbolized thereby, under the Trademark Agreement, the Agent, without representation or warranty of any kind, hereby absolutely, unconditionally and irrevocably re-transfers, re-conveys and re-assigns all such right, title and interest to the Company. The Agent authorizes and requests that the Commissioner for Trademarks of the USPTO, the Registrar of Trade-marks of the CIPO and any other applicable government officer or relevant governmental authority record this Release.
