AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This Amended and Restated Trademark Security Agreement dated as of January 4, 2019 (this "Trademark Security Agreement"), is made by each signatory hereto listed under "Pledgors" (each a "Pledgor" and collectively, the "Pledgors"), in favor of Wilmington Trust, National Association, in its capacity as Notes Collateral Agent for the Holders under the Indenture (in such capacity, together with its successors and permitted assigns, the "Notes Collateral Agent") pursuant to that certain Indenture, dated as of December 19, 2017 (as amended, restated, amended and restated, supplemented, extended, waived, renewed, replaced, refinanced or otherwise modified from time to time, the "Indenture"), by and among Cooke Omega Investments Inc. (the "Company"), Alpha VesselCo Holdings, Inc. ("VesselCo"), and together with the Company, the "Issuers"), the Guarantors party thereto, and the Notes Collateral Agent.

W I T N E S S E T H:

WHEREAS, the Pledgors are party to a Trademark and Security Agreement, dated as of December 19, 2017 (as amended and in effect on and prior to the date hereof, the "Existing Trademark Security Agreement") in favor of the Notes Collateral Agent.

WHEREAS, the Pledgors are party to a Security Agreement, dated as of December 19, 2017 (as amended, restated, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the "Security Agreement") in favor of the Notes Collateral Agent pursuant to which the Pledgors were required to execute and deliver the Existing Trademark Security Agreement.

WHEREAS, the Notes Collateral Agent and the Pledgors have agreed to amend and restate the Existing Trademark Security Agreement in its entirety pursuant to this Trademark Security Agreement, among other things, to account for (i) certain of the Trademark Collateral that were incorrectly listed on Schedule 1 of the Existing Trademark Security Agreement and (ii) the disposition of certain of the Trademark Collateral as permitted by the Indenture.

NOW, THEREFORE, in consideration of the mutual conditions and agreements set forth in this Trademark Security Agreement, and for good and valuable consideration, the undersigned hereby agree that the Existing Trademark Security Agreement shall be amended and restated in its entirety to read as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement, or if not defined therein, in the Indenture.

SECTION 2. Grant of Security Interest in Trademark Collateral. Each Pledgor hereby pledges and grants to the Notes Collateral Agent for the benefit of the Holders a Lien on and security interest in all of the right, title and interest of such Pledgor in, to and under all the following Pledged Collateral, in each case excluding Excluded Property (collectively, the "Trademark Collateral"):

(a) all Trademarks, including, without limitation, the United States registered Trademarks and applications for Trademark registration, listed on Schedule 1 attached hereto,

together with any and all (i) rights and privileges arising under applicable Law with respect to the use or ownership of any of the foregoing, (ii) goodwill associated therewith, (iii) continuations, extensions and renewals thereof and amendments thereto; and

(b) all Proceeds of any and all of the foregoing.

Notwithstanding the foregoing, no grant of any Lien or security interest shall be deemed granted hereunder on or in any "intent to use" Trademark application for which a Statement of Use or Amendment to Allege Use, as applicable, has not been filed and accepted with the United States Patent and Trademark Office.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Notes Collateral Agent pursuant to the Security Agreement, and the Pledgors hereby acknowledge and affirm that the rights and remedies of the Notes Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Recordation. Each Pledgor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Trademark Security Agreement in the United States Patent and Trademark Office, the Canadian Intellectual Property Security Office and any other applicable governmental office.

SECTION 5. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Trademark Security Agreement by signing and delivering one or more counterparts. Delivery of an executed counterpart of this Trademark Security Agreement by facsimile or other electronic means shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement.

SECTION 6. Governing Law. This Trademark Security Agreement shall be construed in accordance with and governed by the law of the State of New York. The terms of Section 14.08 and Section 14.09 of the Indenture are incorporated herein mutatis mutandis.

SECTION 7. Regarding the Notes Collateral Agent. Notwithstanding anything to the contrary herein, whenever reference is made in this Trademark Security Agreement to any discretionary action by, consent, designation, specification, requirement or approval of, notice, request or other communication from, or other direction given or action to be undertaken or to be (or not to be) suffered or omitted by the Notes Collateral Agent or to any election, decision, act, opinion, acceptance, use of judgment, expression of satisfaction or other exercise of discretion, rights or remedies to be made (or not to be made) by the Notes Collateral Agent, it is understood that in all cases the Notes Collateral Agent shall be fully justified in failing or refusing to take any such action under this Trademark Security Agreement if it shall not have received such written instruction, advice or concurrence of, and indemnity from, the Required Holders of the


Notes, as it deems reasonably appropriate. For the avoidance of doubt, the Notes Collateral Agent shall not act hereunder unless and until it has received appropriate written instruction, advice or concurrence of, and indemnity from the Required Holders of the Notes. In acting hereunder, the Notes Collateral Agent shall be entitled to all of the rights, privileges, protections and immunities provided to it under the Indenture as if fully set forth herein.




