
**RELEASE OF SECURITY INTEREST IN
TRADEMARKS**

WHEREAS, SILICON VALLEY BANK, a California corporation (the "Bank"), holds a security interest in certain intellectual property assets of HUBSPAN, INC., a Washington corporation ("Grantor"), pursuant to (i) the Security Agreement between Bank and Grantor, effective on or about June 28, 2013, (ii) the Intellectual Property Security Agreement between Bank and Grantor, effective on or about July 2013, (iii) the Security Agreement between Bank and Grantor, effective on or about March 29, 2017 and (iv) the Intellectual Property Security Agreement between Bank and Grantor, effective on or about March 29, 2017 (in each case, as the same may be amended, restated, supplemented, extended or otherwise modified from time to time) (collectively, the "Security Agreements"), and certain such Security Agreements were recorded with the United States Patent and Trademark Office at Reel 6023/Frame 0534 on March 31, 2017.

NOW, THEREFORE, for value received, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby (a) absolutely, unconditionally and irrevocably terminates, extinguishes, forever discharges and releases each security interest in the Trademarks (as defined in the Security Agreements) that was granted under the Security Agreements and any and all other security interests Bank or its predecessors, successors, assigns and transferees may have in the Trademarks, including in the Trademarks set forth herein on Schedule I and in the goodwill of the business of Grantor connected with and symbolized by the Trademarks and (b) acknowledges and agrees that the Security Agreements have been terminated. The Bank authorizes and requests the Director of Patents and Trademarks of the United States of America to record this Release of Security Interest in Trademarks (the "Release") and agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request in order to perfect, confirm or evidence the release of Bank's security interest in the Trademarks. Bank hereby represents and warrants that it has full authority to execute and deliver this Release. This Release shall be governed by and construed in accordance with the law of the State of New York. This Release shall be binding upon the Banks' representatives, successors, assigns and transferees.

IN WITNESS WHEREOF, the Bank, by its duly authorized officer, has executed this Release on this 17th day of December, 2018.
