**UNITED STATES TRADEMARK SECURITY AGREEMENT**

This UNITED STATES TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of January 3, 2019, is made by and between Manufacturers and Traders Trust Company, (together with its successors and assigns, in such capacity, the “**Lender**”); and Singer NY, LLC, a Delaware limited liability company (“**Singer NY**”), and Singer Equipment Company, Inc., a Delaware corporation (“**Singer Equipment**”) (each together with their respective successors and permitted assigns, a “**Grantor**,” and collectively, the “**Grantors**”).

WHEREAS, this Agreement shall be filed with the United States Patent and Trademark Offices to, among other things, indicate that Lender is collateral assignee with respect to the Trademarks (as defined herein) listed on Schedule A hereto;

WHEREAS, Grantors own certain trademarks, including the applications and registrations thereof, together with the goodwill of the business connected with the use of and symbolized by the trademarks and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, set forth on Schedule A hereto (collectively, the “**Trademarks**”); and

WHEREAS, Grantors and Lender executed the following General Security Agreements: (1) between Singer NY and Lender, dated June 15, 2011; (2) between Singer NY and Lender dated September 12, 2017; (3) between Singer Equipment and Lender dated April 30, 2009; and between Singer Equipment and Lender dated September 12, 2017 (as amended, restated, amended and restated, modified or supplemented from time to time, collectively, the “**Security Agreements**”), pursuant to which Grantors agreed to grant and granted to Lender a security interest in certain of its assets to secure obligations owing to Lender.

NOW, THEREFORE, for good and valuable consideration, Grantors hereby pledge and grant (and confirm and ratify all other pledges and grants heretofore made to Lender) to Lender a security interest and lien in and to the Trademarks to secure the Obligations (as defined in the Security Agreements), subject to the terms and conditions of the Security Agreements.
