WHEREAS, the Debtor has satisfied Debtor's obligations to the Secured Party with respect to said security agreements;



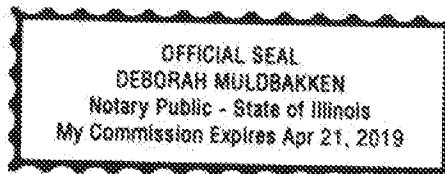
