ARTICLES OF CONVERSION

In accordance with Section 3-901 of the Maryland General Corporation Law and Section 4A-1101 of the Maryland Limited Liability Company Act, Maryland Physicians Edge, Inc., a Maryland corporation (the “**Converting Entity**”) will convert into a Maryland limited liability company (the “**Conversion**”) pursuant to these Articles of Conversion.

THIS IS TO CERTIFY THAT:

FIRST: The name of the Converting Entity is “Maryland Physicians Edge, Inc.” The Converting Entity was first created on October 16, 2013 under the laws of the State of Maryland, on which date the Converting Entity’s original articles of incorporation were filed with the Maryland State Department of Assessments and Taxation (“**SDAT**”).

SECOND: The name of the limited liability company to which the Converting Entity will be converted is “Maryland Physicians Edge, LLC” (the “**Converted Entity**”). The Converted Entity will be organized under the laws of the State of Maryland.

THIRD: The conversion of the Converting Entity into the Converted Entity and these Articles of Conversion have been approved in accordance with the provisions of Title 3, Subtitle 9 and Title 4A, Subtitle 11 of the Corporations and Associations Article of the Annotated Code of Maryland.

FOURTH: Upon the completion of the Conversion in accordance with the Maryland General Corporation Law and the Maryland Limited Liability Company Act, the Converted Entity shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Converting Entity, and the Conversion will have the effects set forth herein and in the Maryland General Corporation Law and the Maryland Limited Liability Company Act. The manner and basis of exchanging the outstanding shares of stock of the Converting Entity into membership interests of the Converted Entity shall be as follows: Each share of common stock of the Converting Entity shall, without any action on the part of any stockholder of the Converting Entity, be converted into and exchanged for one Unit (as that term is defined in the Converted Entity’s Operating Agreement.

FIFTH: These Articles of Conversion shall be effective on May 16, 2017 at 1:01 ~~a.m.~~/p.m..

SIXTH: The resolutions adopted by the Board of Directors of the Converting Entity approving these Articles of Conversion authorized Dale Scholler to attest these Articles of Conversion as an agent of the Converting Entity.

SEVENTH: The undersigned acknowledges these Articles of Conversion to be the act and deed of the Converting Entity and the Converted Entity and, further, as to all matters or facts required to be verified under oath, the undersigned acknowledges that, to the best of his

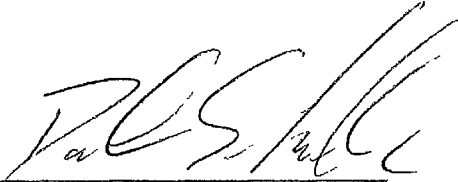

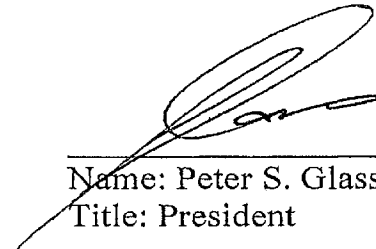

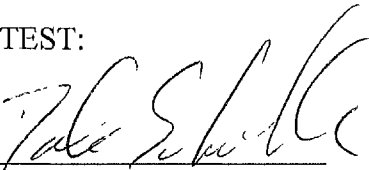
