PARTIAL RELEASE OF SECURITY INTERESTS

WHEREAS, pursuant to the Grant of Security Interest in Trademarks and Patents ("Security Agreement") entered into on August 5, 2016, among Colorado Trading & Clothing Company, a Colorado corporation ("Grantor") and MB Financial Bank, N.A., ("Grantee"), Grantor granted a security interest to Grantee in certain Patents and Trademarks (as defined in the Security Agreement), and the goodwill of Grantor's business connected with and symbolized by the Trademarks, and in all proceeds, indemnities, warranties and guaranties, including all other forms of collateral identified in the Security Agreement (collectively the "Secured Property"); and

WHEREAS, such Security Agreement was recorded within the records of the United States Patent and Trademark Office at reel 005946, frame 0001 on December 12, 2016; and

WHEREAS, Grantee desires to formally release its security interest and all right, title and interest of Grantee in and to the Trademark "Life is a Workout," Serial Number 86253734 filed April 16, 2014 ("Trademark 1"); and

WHEREAS, Grantee desires to formally release its security interest and all right, title and interest of Grantee in and to the Trademark "Life is a Workout," Serial Number 86978681, Registered Number 4970636 filed April 16, 2014 ("Trademark 2"); and

WHEREAS, pursuant to the Security Agreement, Grantee agreed to execute and deliver to Grantor all instruments as may be necessary or proper to extinguish Grantor's security interests in Trademark 1 and Trademark 2;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee does hereby release and forever discharge and reconvey to Grantor all of Grantee's security interest in Grantee's right, title, and interest in, to and under the trademark registrations identified above, so that it is as if the security interest had never been granted by Grantor.

THIS PARTIAL RELEASE of Security Interests only releases the security interest in Trademark 1 and Trademark 2 and does not affect the security interest in the remaining trademarks and patents described in the Security Agreement.
