FIRST: The Board of Directors of the Corporation, by unanimous written consent, duly adopted and approved of resolutions setting forth a proposed amendment to the Corporation's Fifth Amended and Restated Certificate of Incorporation, declaring the proposed amendment to be advisable, and submitting it to the stockholders of the Corporation for their consideration.
