Assignor hereby requests the United States Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Trademarks.


Assignor shall take all further actions, and provide to Assignee and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignee or its successors, assigns or other legal representatives to more fully and effectively effectuate the purposes of this Assignment.
