## INTELLECTUAL PROPERTY SECURITY AGREEMENT

**THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT** is entered into as of December 31, 2018 by and between **TRUE NORTH CUSTOM PUBLISHING, LLC**, a Tennessee limited liability company ("**TNCP**"), and **GLADSTONE CAPITAL CORPORATION**, a Maryland corporation (the "**Buyer**").

### RECITALS

**A.** TNCP and the other Sellers (as defined therein) are parties to that certain Securities Purchase Agreement dated as of February 26, 2010 (as amended, modified or supplemented from time to time the "**Securities Purchase Agreement**"). Capitalized terms used herein are used as defined in the Securities Purchase Agreement.

**B.** Pursuant to the Security Agreement and the other Investment Documents, TNCP has granted to the Buyer first priority security interests in all of TNCP's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral, including without limitation, its Intellectual Property, to secured the Obligations.

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of the Obligations, TNCP hereby represents, warrants, covenants and agrees as follows:

### AGREEMENT

To secure the Obligations, TNCP hereby grants and pledges to the Buyer a security interest in all of TNCP's right, title and interest in, to and under its Intellectual Property (including without limitation those copyrights and trademarks (including without limitation the goodwill associated therewith) listed on Exhibits A and B hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

The security interests are granted in conjunction with the security interests granted to the Buyer under the Security Agreement and the other Investment Documents. The rights and remedies of the Buyer with respect to the security interests granted hereby are in addition to those set forth in the Security Agreement and the other Investment Documents, and those which are now or hereafter available to the Buyer as a matter of law or equity. Each right, power and remedy of the Buyer provided for herein or in the Security Agreement or any of the Investment Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by the Buyer of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Security Agreement or any of the other Investment Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including the Buyer, of any or all other rights, powers or remedies.

TNCP represents and warrants that Exhibits A and B attached hereto set forth any and all Intellectual Property rights in connection to which such Seller has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable, and that are active.

TNCP hereby acknowledges and agrees that the Buyer may, from time to time and without notice to TNCP, amend Exhibits A and B hereto to reflect changes in TNCPs right, title and interest in, to and under any copyrights and trademarks; *provided* that TNCP acknowledges and agrees that the Buyer's failure to so amend such Exhibits shall not limit or impair the Buyer's security interest in any Intellectual Property.

IN WITNESS WHEREOF, the parties have caused this Intellectual Property Security Agreement to be duly executed by their officers thereunto duly authorized as of the first date written above.
