Pursuant to Title 6, Section 18-209 of the Limited Liability Company Act (the "Act"), Raycom Sports Network, Inc., a North Carolina corporation ("RSNI" or the "Surviving Corporation"), does hereby certify as follows with respect to the merger of the Disappearing Company (as defined below) with and into the Surviving Corporation:

FIRST: The name of the surviving corporation in the merger is Raycom Sports Network, Inc., a North Carolina corporation.

SECOND: The name of the disappearing company in the merger is Raycom Sports Network, LLC, a Delaware limited liability company (collectively, the "Disappearing Company").

SIXTH: The merger shall be effective upon filing of this Certificate of Merger with the Secretary of State of the State of Delaware in accordance with the provisions of Sections 18-204 and 18-209 of the Act (the "Effective Time").

SEVENTH: The organizational documents of the Surviving Company shall be in the form of the Certificate of Incorporation of RSNI, as in effect immediately prior to the Effective Time.
