CERTIFICATE OF MERGER

OF

ARTSTOR INC.

INTO

ITHAKA HARBORS, INC.

Under Section 906 of the Not-for-Profit Corporation Law

**FIRST:** The name and state of incorporation of each constituent corporation that is merging is: (i) ARTstor Inc., a Delaware nonprofit nonstock corporation which was incorporated on December 9, 2002 ("Artstor") and qualified to do business in New York effective August 28, 2003, and (ii) Ithaka Harbors, Inc., a New York not-for-profit corporation which was incorporated on July 31, 1995 under the name "JSTOR" ("ITHAKA", together with Artstor, the "Constituent Corporations").

**SECOND:** ITHAKA will be the surviving corporation (the "Surviving Corporation"), and its name will not be changed.

**THIRD:** ITHAKA does not have members. ITHAKA is the sole member of Artstor. There are no holders of certificates evidencing capital contributions or subventions for either Artstor or ITHAKA.

**FOURTH:** The Certificate of Incorporation of the Surviving Corporation will be the Certificate of Incorporation of ITHAKA immediately prior to the Effective Time, unless and until the same is amended in accordance with applicable law.

**FIFTH:** The merger is to become effective on December 31, 2018 (the "Effective Time").

**SIXTH:** The Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations pursuant to Title 8, Section 256 of the General Corporation Law of the State of Delaware and Section 903 of the New York Not-for-Profit Corporation Law. The Board of Trustees of Artstor adopted the Plan of Merger on October 25, 2017. The Board of Trustees of ITHAKA adopted the Plan of Merger on October 25, 2017. ITHAKA, as sole member of Artstor, adopted the Plan of Merger on July 25, 2018.

**SEVENTH:** The Plan of Merger is on file at 101 Greenwich Street, 18<sup>th</sup> Floor, New York, New York 10006, the place of business of the Surviving Corporation.





1. By Verified Petition of Kevin M. Guthrie, President of Ithaka Harbors, Inc. ("ITHAKA"), and Nancy Kopans, Secretary of ARTstor Inc. ("Artstor"), sworn to on October 10, 2018, ITHAKA and Artstor applied to the Attorney General pursuant to Article 9 of the Not-for-Profit Corporation Law ("N-PCL") for approval of an application to merge.
2. The surviving corporation will be ITHAKA.

Based on a review of the Verified Petition and the exhibits thereto, and the verifications of Kevin M. Guthrie, President of ITHAKA, and Nancy Kopans, Secretary of Artstor, the Attorney General has determined that the Petitioners have complied with the provisions of Article 9 of the N-PCL applicable to the merger of not-for-profit corporations, and

neither the Petitioners nor any third party having raised with the Attorney General any objections to the proposed merger, and it appearing to the satisfaction of the Attorney General that the interests of the constituent corporations and the public interest will not be adversely affected by the merger, the Agreement and Plan of Merger is approved and the Certificate of Merger is authorized to be filed with the Department of State.

A copy of the Certificate of Merger, as filed with the Department of State, shall be sent to the Attorney General's office within 10 days of its filing.
