TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this “**Assignment**”), dated as of December 31, 2018, is made by Zoom Management, Inc., an Oregon corporation (“**Assignor**”), in favor of PeaceHealth Networks On Demand, LLC, a Washington limited liability company (“**Assignee**”), pursuant to the terms of that certain Asset Purchase Agreement, dated as of December 18, 2018 (the “**Agreement**”), by and among Assignor, PeaceHealth Networks, a Washington nonprofit corporation, Assignee and each of the parties set forth on Exhibit A to the Agreement. Capitalized terms used but not defined herein shall have the meanings given such terms in the Agreement.

WHEREAS, under the terms of the Agreement, Assignor has sold to Assignee, among other assets, certain intellectual property of Assignor, and Assignor has agreed to execute and deliver this Trademark Assignment to convey, transfer, and assign the intellectual property set forth herein to Assignee, which Assignment may be recorded with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s right, title, and interest in and to the following (the “**Transferred Trademarks**”), together with the goodwill of the business connected with the use of, and symbolized by, or associated with the Transferred Trademarks:

(a) the trademark registrations and trademark applications set forth in Schedule 1 hereto and all issuances, extensions, and renewals thereof; provided that, with respect to the United States intent-to-use trademark applications set forth on Schedule 1, the transfer of such applications accompanies, pursuant to the Agreement, the transfer of Assignor’s business, or portion of the business to which the trademark pertains, and that business is ongoing and existing;

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing under this Section 1 provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing under this Section 1; and

(d) any and all claims and causes of action with respect to any of the foregoing under this Section 1, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Terms of the Agreement. The parties hereto acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.

3. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, Assignor shall, at Assignee's sole cost and expense, take such reasonable steps and actions, and provide such reasonable cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect this Assignment of the Transferred Trademarks to Assignee, or any assignee or successor thereto

4. Counterparts. This Assignment may be executed electronically (including pdf or any electronic signature complying with the U.S. Federal ESIGN Act of 2000, e.g., www.docuSign.com) and in two or more counterparts, each of which shall constitute an original and all of which shall be considered one and the same agreement. Counterpart signature pages may be delivered via facsimile transmission, electronic mail or other transmission method and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes.

5. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. Governing Law, Entire Agreement, etc. This Assignment shall be governed by and construed in accordance with the laws of the State of Oregon, without regard to its conflicts of law principles. This Assignment, the Assignment and Assumption Agreement, and the Agreement contain the entire agreement and understanding between the parties hereto with respect to the subject matter hereof and supersede all prior agreements and understandings relating to such subject matter.






