TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("**Assignment**"), effective this 16th day of January 2019, is made and entered into by and between **VSS Monitoring, Inc.**, a corporation operating under the laws of the State of Delaware, with an address at 930 De Guigne Drive, Sunnyvale, California 94085 ("**Assignor**"), and **Netscout Systems, Inc.**, a corporation operating under the laws of the State of Delaware, with an address at 310 Littleton Road, Westford, Massachusetts 01886 ("**Assignee**") (each a "**party**" and collectively, the "**parties**").

WHEREAS, Assignor is the owner of the trademarks, trademark registrations and trademark applications, including any and all goodwill symbolized thereby, set forth on the Schedules hereto ("**Trademarks**"); and

NOW THEREFORE, for the consideration of Ten (\$10.00) U.S. Dollars, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


1. **Assignment.** Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademarks, including all rights therein provided by international conventions and treaties, as well as any and all rights derived from use of the Trademarks, either by itself or by recorded licensees, including any and all goodwill symbolized thereby, as well as the right to sue for past, present and future infringement thereof. Assignor shall timely execute and deliver any additional documents and perform such additional acts necessary or desirable to record and perfect the interest of Assignee in and to the Trademarks.

2. **Counterparts.** This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.


3. **Assignment of Licenses.** The parties hereby agree in that all rights and obligations which derive from any and all license agreements into which the Assignor has ever entered with respect to the Trademarks, and which have been properly recorded with the U.S. Trademark Office, against each of said Trademarks included in this agreement, will also be assigned to the Assignee, by virtue of the present agreement, where applicable. In light of the present assignment of rights said provision will be regarded as effective as of the date first written above.
