TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT, dated as of August 30, 2018, is made by Maurice Sporting Goods LLC ("**Seller**"), a Delaware limited liability company, located at 400 Skokie Boulevard, Suite 405, Northbrook, Illinois 60062, U.S.A., in favor of ALAC Enterprises, Inc. ("**Buyer**"), a Florida corporation, located at 13571 SW 135th Avenue #201, Miami, Florida 33176, U.S.A., the purchaser of certain assets of Seller pursuant to the Inventory and Asset Purchase Agreement made as of August 30, 2018 between Buyer, on the one hand, and Seller, on the other hand (the "**Purchase Agreement**").

WHEREAS, under the terms of the Purchase Agreement, Seller has conveyed, transferred, and assigned to the buyer, among other assets, certain intellectual property of Seller, and has agreed to execute and deliver this Trademark Assignment to buyer;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably conveys, transfers, and assigns to Buyer, and Buyer hereby accepts, all of Seller's right, title, and interest throughout the world in and to the following: (a) the trademark registrations set forth on Schedule 1 hereto and all extensions and renewals thereof (the "**Assigned Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks; (b) all rights of any kind whatsoever of Seller accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing (other than sums due Seller under the Purchase Agreement); and (d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
2. Recordation and Further Actions. Seller hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities in any applicable jurisdiction to record and register this Trademark Assignment upon request by Buyer.
3. Terms of the Inventory and Asset Purchase Agreement. The parties hereto acknowledge and agree that this Trademark Assignment is entered unto pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Buyer with respect the Assigned Trademarks. The representations, warranties, covenants, agreement, and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided herein.

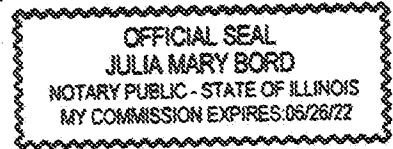

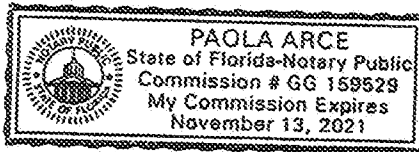
