**DECLARATION OF ALLISON R. IMBER, ESQ.**

I, Allison R. Imber, Esq., hereby declare and state as follows:

1. I am a resident of the State of Florida, over the age of 18, and competent to make this Declaration. The facts stated in this Declaration are within my personal knowledge and are true to the best of my knowledge.

2. I represent Correct Craft IP Holdings, LLC, owner of the marks listed in the attached Exhibit A (collectively, the "Marks").

3. There was a filing error in the Release by Secured Party recorded May 10, 2011 against the Marks at Reel/Frame 4538/0083, which lists the Assignor as Correct Craft, Inc. and the Assignee as RBC Bank (USA). Because this was a Release of a security interest held by RBC Bank (USA), the Assignor should have been listed as RBC Bank (USA) and the Assignee should be listed as Correct Craft, Inc. instead of vice versa. Accordingly, Correct Craft IP Holdings, LLC respectfully requests that the record be updated to reflect the Assignor as RBC Bank (USA) and the Assignee as Correct Craft, Inc.

4. The undersigned, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. §1001, and that such willful false statement may jeopardize the validity of this document, declares that she is properly authorized to execute this document on behalf of Correct Craft IP Holdings, LLC, and all statements made of her own knowledge are true and that all statements made on information and belief are believed to be true.
