**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of October 1, 2018 (the “**Effective Date**”) by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, a national banking association (the “**Collateral Agent**”) in favor of **TRADER CORPORATION.**, a corporation organized under the laws of British Columbia (the “**Grantor**”).

**WHEREAS**, Grantor executed and delivered that certain Second Lien Canadian Security Agreement, dated as of September 28, 2016, in favor of the Collateral Agent (the “**Security Agreement**”; capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Security Agreement);

**WHEREAS**, pursuant to the terms of the Security Agreement, Grantor duly authorized the execution, delivery and performance of that certain Intellectual Property Security Agreement, effective as of October 18, 2016, in favor of the Administrative Agent (the “**IP Security Agreement**”);

**WHEREAS**, pursuant to the IP Security Agreement, Grantor pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in all of Grantor’s right, title and interest in, to and under all of the Trademarks (as defined therein), including, without limitation, the trademarks set forth on Schedule A;

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office on October 20, 2016 at Reel/Frame 5905/0777; and

**WHEREAS**, Grantor has paid or caused to be paid all of the Secured Obligations (other than Unasserted Contingent Obligations) and has terminated all Commitments.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the IP Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has in, to and under the Trademarks.
