**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of December 31, 2018, and made by CRYSTAL FINANCIAL LLC, as the Term Agent, having an office at Two International Place, 17th Floor, Boston, MA 02110 ("Term Agent"), to CARITE CORPORATE, LLC, a Michigan limited liability company (the "Grantor"), with its chief executive office at 101 W. Fourteen Mile Road, Madison Heights, MI 48071.

WHEREAS, Grantor and Term Agent entered into that certain Trademark Security Agreement, dated December 14, 2017 (the "Security Agreement"), in which a security interest was granted by Grantor in favor of Term Agent in certain Trademarks (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 19, 2017, at Reel 6280, Frame 0096; and

WHEREAS, Term Agent now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Term Agent hereby states as follows:

1. Definitions. The term "Trademarks", as used herein, shall have the meaning set forth in the Security Agreement and shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof, including in the trademarks listed on Schedule A attached hereto.

2. Release of Security Interest. Term Agent hereby terminates the Security Agreement, and terminates, releases and discharges its security interest in the Trademarks and reassigns to Grantor all right, title and interest it may have in and to the Trademarks without recourse and without any representation or warranty.



