## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of January 17, 2019 by **SILICON VALLEY BANK**, in its capacity as Administrative Agent for certain secured parties (the “*Assignee*”), in favor of **CIELO, INC.**, a Wisconsin corporation formerly known as Pinstripe, Inc. (the “*Grantor*”). Capitalized terms used but not defined herein have the meaning set forth in the Trademark Security Agreement.

**WHEREAS**, the Grantor and the Assignee and certain other parties and certain Lenders party thereto entered into that certain Credit Agreement, dated as of July 17, 2013 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “*Credit Agreement*”);

**WHEREAS**, in connection with the Credit Agreement, (i) the Grantor, the Assignee and certain other parties entered into that certain Guarantee and Collateral Agreement, dated as of July 17, 2013 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “*Guarantee and Collateral Agreement*”), (ii) the Grantor executed and delivered a Trademark Security Agreement, dated as of July 17, 2013 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “*Trademark Security Agreement*”), recorded with the United States Patent and Trademark Office (“*USPTO*”) on July 17, 2013, at Reel 5072, Frame 0860; and (iii) the Grantor executed and delivered a Supplement to Trademark Security Agreement, dated as of January 12, 2016 that supplemented that certain Trademark Security Agreement (the “*Supplemented Trademark Security Agreement*”) recorded with the USPTO on January 12, 2016, at Reel 5708, Frame 0186;

**WHEREAS**, pursuant to the terms and conditions of the Guarantee and Collateral Agreement and the Supplemented Trademark Security Agreement, the Grantor granted to the Assignee a security interest in all of the Grantor’s right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement) then owned or thereafter acquired by the Grantor;

**WHEREAS**, the Grantor has requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all such Trademarks as herein provided; and

**WHEREAS**, the Assignee has agreed to terminate, release and discharge fully its interest in the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Supplemented Trademark Security Agreement and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto;

2. retransfers, re-conveys and reassigns to the Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by the Assignee, all right, title or interest of the Assignee (if any) in, to or under the Trademarks of the Grantor; and
3. authorizes and requests that this Termination and Release be recorded with the USPTO.


