**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of January 3, 2019 is made by Wilmington Trust, National Association, in its capacity as collateral agent (referred to herein as the “Agent”), in favor of Worldwide Media Services Group, Inc. (f/k/a American Media, Inc., a Delaware corporation (“AMI”)), American Media, LLC, a Delaware limited liability company (“AML”), AMI Celebrity Publications, LLC, a Delaware limited liability company (“AMI Celebrity Publications”) and Weider Publications, LLC, a Delaware limited liability company (“Weider Publications”, collectively the “Companies”), pursuant to that certain Security Agreement, dated as of June 29, 2018 (and as the same may be further amended or modified from time to time, the “Security Agreement”), among the Companies and other parties thereto in favor of the Agent.

**W I T N E S S E T H:**

WHEREAS, in connection with the Security Agreement, each of AMI, AMI Celebrity Publications and Weider Publications executed and delivered a Notice of Security Interests in Trademarks, each dated as of June 29, 2018, in favor of the Agent (collectively, the “Trademark Security Agreements”);

WHEREAS, in connection with an internal reorganization, AMI assigned its interest in the Trademark Security Agreements to AML, pursuant to that certain Assignment of Notice of Grant in Security Interests, by and between AMI and AML, dated as of October 10, 2018;

WHEREAS, pursuant to the Trademark Security Agreements, the Companies granted to the Agent, for the benefit of the Secured Parties, a continuing security interest in all of the Companies’ right, title and interest in and to the Trademarks, including the Trademark registrations and applications identified on Schedule A hereto, together with the goodwill of the business symbolized thereby (the “Released Trademarks”);

WHEREAS, the security interest in the Released Trademarks was recorded with the United States Patent and Trademark Office (the “USPTO”) on July 11, 2018, at Reel/Frame Nos. 6416/0038; 6416/0031; and 6415/0059 and on November 9, 2018, at Reel/Frame No. 6478/0927; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Companies, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreements.

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Companies' right, title and interest in, to and under the Released Trademarks.

SECTION 3. Termination. The Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreements.

SECTION 4. Further Assurances. The Agent hereby authorizes the Companies or the Companies' authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Companies any and all further documents and instruments prepared by the Companies, and do any and all further acts which the Companies (or their agents or designees) reasonably request (at the Companies' sole cost and expense) in order to confirm this Release and the Companies' right, title and interest in, to and under the Released Trademarks.


