TERMINATION AND RELEASE OF AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated January 18, 2019 ("Release"), is made by Silicon Valley Bank ("Bank") in favor of LivHome, Inc., a Delaware corporation (the "Grantor").
