RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARK (this "Release") is made as of January 9, 2019, by PNC BANK, NATIONAL ASSOCIATION, as Successor Collateral Agent (the "Secured Party") to WELLS FARGO BANK, NATIONAL ASSOCIATION, which previously served as Collateral Agent, and KOPPERS INC. (the "Grantor"), in favor of OSMOSE UTILITY SERVICES, INC. (the "Owner").

Recitals

WHEREAS, pursuant to that certain Patent, Trademark and Copyright Security Agreement, dated as of August 15, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor purported to grant to Secured Party, a security interest in and lien upon, among other things, the U.S. trademark set forth on Exhibit A hereto (the "Specified Trademark");

WHEREAS, Grantor has advised the Secured Party that Grantor has no rights in the Specified Trademark (and did not have any rights in the Specified Trademark as of the date it entered into the Security Agreement), and, accordingly, the Specified Trademark was erroneously included as collateral pursuant to the Security Agreement; and

WHEREAS, Grantor has requested that Secured Party execute and deliver this Release in favor of Owner for recordation with the U.S. Patent and Trademark Office to evidence the release of record of any lien in favor of Secured Party encumbering the Specified Trademark;

NOW, THEREFORE, Secured Party and Grantor hereby agree as follows:


1. Recitals. The recitals are hereby incorporated by reference and form a substantive part of this Release.
2. Release of Security Interest. Secured Party hereby terminates and releases any security interest in and lien upon the Specified Trademark in favor of Secured Party including, without limitation, the security interests and liens evidenced by the Security Agreement. Grantor hereby releases any rights it has or purports to have in the Specified Trademark.
3. Recordation. Secured Party and Grantor hereby authorize and request that the Commissioner for Trademarks and any other applicable government officer record this Release.
4. Further Instruments. At Grantor's expense, Secured Party and Grantor hereby agree to execute such further instruments and documents and perform such further acts as Owner may reasonably request to evidence the release of any rights of Secured Party or Grantor in the Specified Trademark.
5. Third Party Beneficiary. Owner shall be a third-party beneficiary of this Release.
