RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of December 31, 2018, by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, in its capacity as administrative agent (“**Administrative Agent**”), in favor of ALL HOLDING COMPANY, LLC, AHC INTERMEDIATE HOLDINGS, LLC (f/k/a BREAKTHROUGH LLC), ALDERFER, LLC, LEN HOLDING COMPANY, LLC, LEIDY’S, LLC, NEIGHBORHOOD MEAT MARKETS, LLC and AHC ACQUISITION HOLDINGS, LLC (each, a “**Grantor**” and collectively, “**Grantors**”).


WHEREAS, pursuant to (i) that certain Guaranty and Collateral Agreement, dated as of November 15, 2016, by and among each of the Grantors party thereto and Administrative Agent, (ii) that certain Amended and Restated Guaranty and Collateral Agreement, dated as of March 21, 2018, by and among each of the Grantors party thereto and Administrative Agent and (iii) that certain Trademark Security Agreement, dated as of November 18, 2016 (the “**Security Agreement**”), executed by Grantors in favor of Administrative Agent and recorded in the records of the United States Patent and Trademark Office on November 18, 2016 at Reel/Frame 005925/0117—0129, each Grantor granted to Administrative Agent a continuing security interest in each Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Security Agreement), including those trademarks set forth on Schedule A hereto.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby (a) terminates and releases all liens and security interests granted by each Grantor in favor of Administrative Agent in the Trademark Collateral, (b) assigns, transfers and delivers to Grantors all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof and (c) terminates and cancels the Security Agreement. Administrative Agent hereby authorizes Grantors or their designee to make filings with the United States Patent and Trademark Office and take further actions necessary to evidence the release and termination of Administrative Agent’s security interests in the Trademark Collateral. Administrative Agent hereby authorizes the governing body of the United States Patent and Trademark Office to record this Release.
