Trademark Assignment Agreement

This Trademark Assignment Agreement ("Agreement") is entered into as of 16 November 2018 ("Effective Date") by and between Haley & Aldrich, Inc. ("Assignor") a Massachusetts corporation, and Emerging Compounds Treatment Technologies, Inc. ("Assignee"), a Massachusetts corporation.

1. **Mark.** The term "mark" as used in this Agreement shall mean the registered trademark, service mark, logos, and designs, together with the goodwill of the business symbolized thereby, and all other rights in the United States and in all countries and territories worldwide and under any international convention ("Mark") identified as follows:

 Description of Mark: The colors blue and grey are claimed as a feature of the mark. The mark consists of the wording "ECT2" in grey. To the left is a square with rounded edges, the top half of which is grey, and the bottom half is blue.
2. **Assignment.** Assignor hereby irrevocably assigns, grants, and transfers to Assignee all rights, title, and interest in and to the Mark in perpetuity. Assignor further authorizes the United States Patent and Trademark Office and all other agencies in jurisdictions outside the United States to record the transfer of this registration.
3. **Representation.** Assignor represents that it owns the entire right, title, and interest in and to the Mark and that all registrations for the Mark are currently valid and in full force and effect.
4. **Consideration.** Assignee shall pay Assignor the sum of One Dollar (\$1.00) on 16 November 2018 in consideration for assignment of the Mark.
5. **Jurisdiction.** This Agreement will be governed and constructed in accordance with the laws of the Commonwealth of Massachusetts, its conflict of laws excepted.
6. **Successors and Assigns.** This Agreement will inure to the benefit of and be binding on the respective successors and permitted assigns of the parties.
7. **Miscellaneous.** Each party agrees to execute such further documents and take such further steps as the other party reasonably determines may be necessary or desirable to effectuate the purposes of this Agreement. It is the intention of the parties that in the event a court of competent jurisdiction finds that any provision or portion of this Agreement is invalid or unenforceable for any reason, the balance and remainder of this Agreement shall remain in effect and enforceable to the extent possible under the circumstances then existing.
