TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of November 21, 2018 by **SILICON VALLEY BANK**, in its capacity as Administrative Agent for certain secured parties (the "*Assignee*") in favor of **CLEAR POND TECHNOLOGIES INC.**, a Delaware corporation (the "*Grantor*");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Trademark Security Agreement and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including the trademark identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
