**PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST**

This Partial Release of Trademark Security Interest (“Release”) is given on this 22nd day of January 2019, by ANTARES CAPITAL LP, as the administrative agent (the “Administrative Agent”) for each of the Secured Parties to ALPHA MEDIA LLC (the “Grantor”), as follows:

WHEREAS, notwithstanding the Administrative Agent’s termination and release as to the Trademarks described herein, the Trademark Security Agreement remains in full force and effect and the Administrative Agent maintains all other security interests, pledges, assignments, mortgages and liens of record granted to it under the Trademark Security Agreement

NOW THEREFORE, the Administrative Agent hereby releases any security interest it may have in the Trademarks specifically listed on Schedule A, and reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantor.
