INTELLECTUAL PROPERTY LIEN RELEASE

This INTELLECTUAL PROPERTY LIEN RELEASE (the “Release”) is made and entered into on this 1st day of November, 2018, by FIFTH THIRD BANK, an Ohio banking corporation (the “Secured Party”), in favor of VISIONARY INTEGRATION PROFESSIONALS, LLC, a Delaware limited liability company, and MERIDIAN KNOWLEDGE SOLUTIONS, LLC, a Virginia limited liability company (collectively, the “Debtor”).

FOR GOOD AND VALUABLE CONSIDERATION, the mutuality, receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby (i) terminates that certain Third Amended and Restated Intellectual Property Security Agreement, dated March 1-. 2017 (the “IP Security Agreement”) and (ii) acknowledges that the termination of the IP Security Agreement shall, among other things, cause the Secured Party’s security interest in the Intellectual Property (as defined in the IP Security Agreement) to be released and discharged in full. For the avoidance of doubt, the Intellectual Property includes, but is not limited to, the live trademarks and applications identified on Exhibit A attached hereto (the “Trademarks”). The Secured Party agrees, or authorizes the Debtor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Debtor to evidence the release and termination of the Secured Party’s security interests in the Trademarks as recorded in the records of the United States Patent and Trademark office and as referenced on Exhibit A attached hereto.

This Release shall be binding upon the Secured Party and its successors and assigns and shall inure to the benefit of the Debtor and its successors and assigns.
