RELEASE OF TRADEMARK SECURITY INTERESTS

WHEREAS, SunTrust Bank, a Georgia Banking Corporation (together with its successors and assigns, the "Administrative Agent"), with a principal place of business at 3333 Peachtree Road, Atlanta, Georgia 30327 was designated as the Administrative Agent pursuant to a certain Credit Agreement dated October 3, 2012 by and among Acorn Media Group, Inc. ("Grantor"), a District of Columbia corporation, with a principal place of business at 8515 Georgia Avenue, Suite 650, Silver Spring, Maryland 20910 ("Grantor") and certain of its Affiliates, the Administrative Agent, and the Lenders (the "Credit Agreement").

NOW, THEREFORE, for good and valuable consideration, the Administrative Agent does hereby release and discharge all trademark-related security interests granted to it by Grantor in the Security Agreement, including without limitation the security interests in the trademark shown on Schedule A, attached hereto and incorporated herein by reference, the debt secured thereby having been paid and satisfied in full.

The Administrative Agent has no remaining interest whatsoever under the Security Agreement either in the trademark shown on Schedule A, or in any other registered or unregistered trademarks now owned or formerly owned by Grantor.

The Administrative Agent hereby consents that a copy of this Release of Trademark Security Interests shall be deemed a full legal and formal equivalent of any like document that may be required in any country for any purpose.
