**RELEASE OF TRADEMARK SECURITY**

**WHEREAS**, the 2015 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 15, 2015 at Reel 5517, Frame 0682; and


**WHEREAS**, the Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantor.
