## **RELEASE OF TRADEMARK SECURITY AGREEMENT**

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 23, 2016, that was recorded January 10, 2017, at the United States Patent and Trademark Office on Reel: 5963; Frame: 0256 (the "Trademark Security Agreement"), Kaufman Hall & Associates, LLC, a Delaware limited liability company ("KHA"), pledged and granted to SUNTRUST BANK, as Administrative Agent (the "Administrative Agent"), for the benefit of the Secured Parties, to secure the Secured Obligations, a Lien on and security interest in the Trademark Collateral, including the trademarks listed on Schedule I attached hereto; and

WHEREAS, KHA has requested and the Administrative Agent has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its continuing security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement referred to therein.

2. Release of Security Interest. The Administrative Agent hereby, without any representation and warranty and without any recourse (a) terminates the Liens and security interests created under the Trademark Security Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral, and (d) terminates the Trademark Security Agreement except for any provisions therein that expressly survive termination.

The Administrative Agent hereby authorizes KHA and its agents, representatives and designees to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.

IN WITNESS WHEREOF, the undersigned has caused this Release of Trademark Security Agreement to be duly executed as of November 9, 2018.
