ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, as well as any official of any countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARKS and title thereto as the property of ASSIGNEE, its successors and assigns, in accordance with the terms of this Agreement.


