**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

January 18, 2019

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), dated as of the date above, is made by **BSP AGENCY, LLC**, a Delaware limited liability company (as successor in interest to Triangle Capital Corporation), as Agent (the “**Agent**”).

WHEREAS, David M. WHEREAS, Grantor has requested Agent release its security interest in and to all of Grantor’s right, title and interest in the trademark applications and registrations listed on Schedule A hereto (all such trademarks, registrations and applications, collectively, the “**Trademarks**”).

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby RELEASES, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its lien on and security interest in, and right of setoff against, the Trademarks, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Trademarks to the Grantor.


The Agent agrees, at the Grantor’s expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Agent’s security interest in the released collateral described herein.
