INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT

This Intellectual Property Rights Assignment (this "Assignment"), dated October 25, 2018, is by and among MARQUETTE BUSINESS CREDIT SPE I, LLC, a Minnesota limited liability company ("Foreclosing Seller"), SUPER G CAPITAL, LLC, a Delaware limited liability company ("Junior Lender"), KISS MY FACE, LLC, a Delaware limited liability company ("Borrower" and together with Foreclosing Seller and Junior Lender, collectively, "Assignor"), and KMF IP HOLDINGS LLC, a Delaware limited liability company ("Assignee").

WHEREAS, pursuant to that certain Secured Party Sale Agreement and Joint Escrow Instructions dated as of October 25, 2018 (the "Sale Agreement"; capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Sale Agreement), Foreclosing Seller is selling, transferring, assigning, conveying and delivering to Assignee any and all of Assignor's right, title and interest in and to the Property (as defined in the Sale Agreement) of, including certain intellectual property owned by Borrower (the "Purchased IP");

WHEREAS, Foreclosing Seller and Junior Lender are parties to a Debt and Lien Subordination Agreement, dated as of June 28, 2018 (the "Subordination Agreement"), pursuant to which Junior Lender subordinated its debt and liens on the terms and conditions set forth therein;

WHEREAS, the Purchased IP includes the trademarks and trademark applications and registrations identified on the attached Schedule A (together with any and all copyright rights therein, the "Marks"), the domain name registrations and social media pages identified on the attached Schedule B (the "Domain Names") and the copyright applications and registrations identified on the attached Schedule C; and

WHEREAS, in accordance with the Sale Agreement, Assignee desires to acquire the Purchased IP, including the Marks and any and all rights of the Assignor therein, including the goodwill of the business associated therewith, all common law rights therein and all worldwide trademark and service mark registrations and applications therefore, including the registrations and applications identified on Schedule A, the Domain Names identified on Schedule B and the Copyrights identified on Schedule C.

NOW, THEREFORE, for good and valuable consideration provided for in the Sale Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby irrevocably conveys, transfers and assigns to Assignee, its successors and assigns, without recourse, representation or warranty of any kind, any and all of Assignor's worldwide right, title and interest in and to the Purchased IP, including without limitation: (a) the Marks, all common-law rights therein, and all registrations and applications therefor identified on Schedule A, together with the goodwill of the business symbolized thereby; (b) the Domain Names identified on Schedule B; (c) the Copyrights identified on Schedule C; (d) all other trademarks, service marks, trade names, domain names, works of authorship, copyrights, trade secrets and all other intellectual property rights included in the Purchased IP, including without limitation all patent, trade secret, copyright and other artistic, literary and moral rights, database, mask work,

trademark, service mark, trade dress right and domain name rights and all goodwill associated therewith, and all other intellectual property and proprietary rights, in any of the foregoing.

Assignor further assigns to Assignee, without recourse, representation or warranty of any kind, any and all of Assignor's rights (i) in and to causes of action and enforcement rights associated with the Marks, Domain Names, Copyrights and other Purchased IP, including, without limitation, all rights to pursue damages, injunctive relief and other remedies for past and future infringement or other violation of the Marks, Domain Names, Copyrights and other Purchased IP and (ii) to apply in any or all countries of the world for patent, trademark and copyright protection for the Purchased IP.

Nothing in this Assignment, express or implied, is intended or shall be construed to confer upon, or give to, any person or entity, other than the parties to this Assignment, any rights, remedies, obligations or liabilities.

This Assignment shall bind and inure to Assignee and Assignor and their respective successors and assigns.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same.


In the event of a conflict between this Assignment and the Sale Agreement, the terms and conditions of the Sale Agreement shall take precedence.





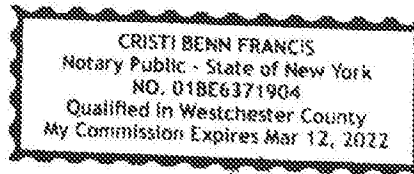
