**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of November 13, 2018, by SOLAR CAPITAL LTD., in its capacity as collateral agent (in such capacity, the "Agent") for the Lenders under the Loan Agreement (each as defined below).

WITNESSETH:

WHEREAS, reference is made to that certain Loan and Security Agreement dated as of September 26, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), among CIANNA MEDICAL, INC., a Delaware corporation (the "Borrower"), the lenders party thereto (the "Lenders") and the Agent;

WHEREAS, pursuant to the Intellectual Property Security Agreement dated as of September 26, 2016 (the "Original IP Security Agreement"), a lien on and security interest (the "Security Interest") was granted by the Borrower to the Agent in certain collateral, including the Intellectual Property Collateral;

WHEREAS, the Original IP Security Agreement was recorded in the United States Patent and Trademark Office at Reel/Frame 5917/0089;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Intellectual Property Collateral including those Trademarks listed on Schedule 1 hereto.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Original IP Security Agreement.
2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Intellectual Property Collateral, and any right, title or interest of the Agent in such Intellectual Property Collateral shall hereby cease and become void.
3. Recordation. The Agent authorizes the Borrower and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Borrower's expense.



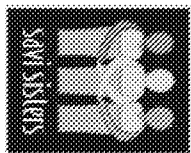
