Pursuant to the provisions of the Utah Revised Business Corporation Act (the "Utah Act"), the undersigned officer of iServe Products, Inc. (the "Corporation") hereby declares and certifies as follows:

FIRST: The name of the Corporation is iServe Products, Inc.

SECOND: Article I of the Amended and Restated Articles of Incorporation of the Corporation, as amended, shall be amended as follows:


The name of the Corporation is Pattern Inc. (the "Corporation").

THIRD: All other provisions of the Amended and Restated Articles of Incorporation of the Corporation, as amended shall remain in full force and effect.



FOURTH: This Second Amendment was adopted and approved pursuant to a joint action by written consent of the Board of Directors and the shareholders of the Corporation effective as of January 4, 2019 (the "Joint Action"). As of the date of the Joint Action, the Corporation had outstanding 94,085,513 shares of Preferred Stock with each share of Preferred Stock entitled to cast ten votes. As of the date of the Joint Action, the Corporation had outstanding 1,552,906 shares of Common Stock with each share of Common Stock entitled to cast one vote. Pursuant to the Joint Action, 940,855,130 votes approved this Second Amendment. The number of votes cast for this Second Amendment were sufficient for approval under the Utah Act.

IN WITNESS WHEREOF, the undersigned officer of the Corporation has executed this Second Amendment effective as of January 4, 2019.

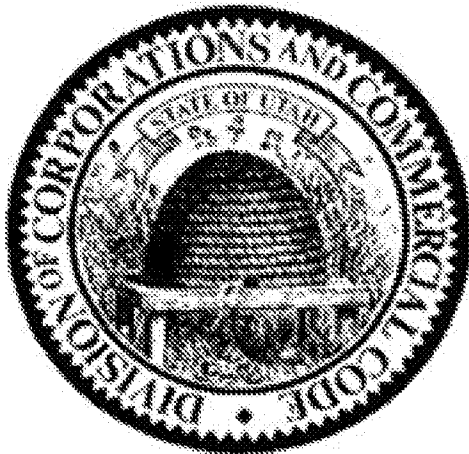
